Paint Spills in Parking Lot

As you have undoubtedly noticed, a large quantity of paint was spilled in the parking lot during trash collection in early September. The Board of Directors is currently discussing responsibility for the damage with our trash removal contractor, AAA Rainbow.

To help prevent future situations such as this, please remember that **paint cannot be disposed of in the trash.** Oil-based paints are considered by Fairfax County to be a Household Hazardous Waste. Although Fairfax County does not classify latex-based paints as hazardous waste, our trash collector, AAA Rainbow, will not pick up any paint products, either latex- or oil-based.

To dispose of unneeded paint, you must take it to the Waste Transfer Station at 4618 West Ox Road, near I-66. Hours of operation for the Household Hazardous Waste facility are Thursday, 8:00 AM to Noon; Friday, 1:00 PM to 5:00 PM; and Saturday, 9:00 AM to 4:00 PM.
