Walkabout Report

On May 5th, twelve homeowners surveyed the curb appeal of the cluster's homes. The purpose of this peer review is to ensure that the quality of the neighborhood as a whole maintained. which helps maintain This year, the review property values. focused primarily on fading paint, broken and missing window grids, warped and sidina. moldv and general maintenance. Most of the homes looked great, however some needed attention. The owners of homes that were found to be in violation of anv Reston Association Standard were sent letters stating that they should correct the problem before their homes are reevaluated in October. Those homeowners that had been sent violation letters during the last walkabout yet failed to take corrective action were cited with an ongoing violation. If these owners do not fix the problems by October, their properties will be reported to the RA Covenants Board. Some homes have been placed on watch status. Although owners of these homes have not been notified, during the next general walkabout in Spring 2003 the committee will carefully reassess these Hopefully by then, the properties. homeowners will have taken the initiative to spruce up their dwellings. Thanks to all of the homeowners that continue to make our neighborhood a well-maintained, beautiful Volunteers for the Spring 2003 place. walkabout committee will be asked for at the annual meeting in April.

Parking and Vehicles

Parking - Just a few reminders on resident and visitor parking in the cluster. There are two (2) assigned parking spaces for each unit in the cluster. Visitor spaces are for guests and visitors. All vehicles shall be in safe operating condition with current

Virginia state license plates (unless active duty military non-residents or new residents of VA - who have 30 days to obtain VA license and registration), county sticker, and safety inspection decals. Only minor spark plugs, air filters, etc.). Recreational vehicles or trucks that do not fit into a standard parking space shall not be parked inside the cluster. No boats or trailers shall be parked in the cluster for more than 24 hours. No parking in the fire lanes, except to load/unload a vehicle. Violation of these rules could result in a fine or towing of the vehicle at the owner's expense. information can be found at the cluster website (www.geocities.com/bwca.geo/), Association the Reston website Fairfax County (www.reston.org). the website (www.co.fairfax.va.us), or in the BWCA Bylaws.

Speeding - The speed limit is 10 MPH. Due to excessive speeding, the Board is considering purchasing removable speed humps, which may require a special assessment. This won't be necessary if people slow down upon entering the neighborhood.

Window Grids

In April 2000, the Reston Association Design Review Board approved the cluster standard option of removing window grids with the stipulation that all windows on any house (front and back) be consistent, i.e., all with grids or all without. What it means is that you can either have the window grids in all of your windows or have them in none of your windows. If you are removing your window grids, please post a message on the BWCA web site message board (see bottom of page for address) before you throw them out!

If you have broken or lost a grid or two, you can now order them directly from Andersen Windows. The number to call is 1-888-888-7020. You will need to know the window glass size and also the numbers and letters etched on the bottom corner of the window. The window grids range in price, anywhere from eight or nine dollars up to seventeen dollars for the larger box-bay window.

Andersen also gave a local dealer as well. Locally you can call Leland L. Fisher Lumber at 301-424-6500, they are located in Rockville, MD. Please check with both for pricing before ordering, as Andersen charges fifteen dollars for shipping and handling for the first grid and five dollars for every additional grid.

New to the area?

Vehicle Registration Information Registration is required before you can get on the road with your motor vehicle, motorcycle, tractor truck, trailer or semi trailer. You can title and register your vehicle at one of Virginia's 73 customer service centers. Once titled, complete an Application for Registration (VSA 14) and certificate. emissions present your Motorcycles are not required to have an emissions inspection. (Note: When you have your vehicle's emissions system inspected, the emissions inspection station will electronically update your DMV vehicle record with the test results immediately. When registering your vehicle, DMV will not ask you for emissions information unless your vehicle failed the test or this information has not been received from the inspection station.) To purchase license plates or decals, you must certify that the vehicle is covered by the minimum insurance requirements or pav uninsured motor vehicle fee. Your insurance carrier must be authorized to conduct business in Virginia. Virginia requires the following minimum coverage: Bodily injury/death of one person \$25,000; Bodily injury/death of two or more persons \$50,000; and Property damage \$20,000. (Note: If liability insurance coverage on a vehicle terminates or cancels during the registration period, either reinsure the vehicle, pay the uninsured motor vehicle fee or surrender the license plates to DMV.)
