The GRINCH Strikes Early — More Hotels <u>BANNING</u> Gideon Bibles!

Each Gideon Bible placed in a hotel room has the potential to reach up to 2,300 people in its estimated six-year life span, and about 25% of travelers read the Bibles in their hotel rooms, according to *The Gideons International*, a group that has been placing Bibles in hotel rooms since 1908. The Gideons say they receive testimonies almost daily of countless lives changed because of the Bibles they've placed, including one man who



planned to commit suicide on Christmas Eve. The man said he threw the Bible onto the hotel room floor and it fell open to John 14, where Jesus says He gives peace. Now the man is a pastor and his family has been

restored. But a growing number of hotels are opting not to allow the placement of Gideon Bibles, according to a recent article in Newsweek magazine. Since 2001, the number of hotels with religious materials in the rooms (e.g. Gideon Bibles) have dropped over 18% according to the American Hotel and Lodging Association. "In the rooms of Manhattan's trendy Soho Grand Hotel guests can enjoy an eclectic selection of underground music, iPod docking stations, flat-screen TVs and even the living company of a complimentary goldfish. But, alas, the word of God is nowhere to be found," the article begins. Such hotels say society is evolving and a younger, hipper generation has no interest in the Bible. In some luxury hotels, the Gideon Bible has been replaced by

romantic 'intimacy kits' which can include sex games/toys, condoms, and a variety of flavored body oils. Such hotels also state that to keep the Gideon Bibles in



their rooms would mean they would have to cater to a variety of other belief systems to avoid singling out Christianity which would appear as 'special treatment.' R. Albert Mohler Jr., president of Southern Baptist Theological Seminary, noted the tragedy that awaits if people aren't given the chance to encounter God's Word when they find themselves troubled in a hotel room. "Are they now to look for salvation and solace from an iPod docking station or a goldfish?" Mohler wrote on his blogsite. "... This development is another reminder that we are living in a time of tremendous cultural and moral change. The absence of Gideons Bibles from an increasing number of hotel rooms tells us something about the secularization, sexualization, and extreme sensitivities of our age," Mohler said. "It also tells us that there will be no Bibles available in those hotel rooms when travelers need them, and that is a tragedy by any measure," he added. "Think of this the next time you are in a hotel room. Check the bedside table for a Gideon Bible. When you find one, thank the hotel management. And, when you have the opportunity, thank the Gideons."

North Carolina School District Slams Door on Gideon Bibles

Attorneys with the Alliance Defense Fund have offered free legal representation to a North Carolina school district that, after being threatened by the

ACLU, has barred Gideons International members from distributing Bibles on elementary school campuses. Hartnett County School District officials recently banned the practice, a long-standing tradition, after the ACLU claimed that it violated the Constitution. "A religious organization such as the Gideons is not second class to other groups that are allowed to distribute literature for voluntary reading



at public schools," said ADF Senior Legal Counsel David Cortman. "The ACLU's claim that the district has somehow broken the law by honoring those equal access rights is not supported by current Supreme Court precedent." Representatives from the ACLU contacted school district officials after receiving a complaint. United States - Parents who feel their unruly, young children need an old-fashioned spanking now and then have the support of the American College of Pediatricians (ACP). Research from the group finds that spanking "can be a useful and necessary part of a successful disciplinary plan." Dr. Den Trumbull, the report's principal author, said: "Spanking is,

at times, necessary with young children, because reasoning and explanation are insufficient in persuading them to have good behavior. "Spanking should be used proactively. The child should be forewarned; it should always be

administered in private, and followed by a loving embrace of the child with an explanation for the reason of the spanking." The ACP statement puts it in direct opposition to the American Medical Association, which condemns spanking and links it to youth violence. Marjorie Lindner-Gunnoe, a psychology professor at Calvin College, said the ACP position is refreshing. "It's nice to see a little bit more balanced approach," she said. "We're getting some multiple views. Massachusetts - Harvard administrators have now decided that Massachusetts' legalization of same-sex "marriage" in 2003 presents a new opportunity. Harvard's Gay, Lesbian, Bisexual and Transgender (GLBT) Law Clinic will provide free and low-cost legal services to



low-income GLBT clients. The clinic will take up cases involving divorce, custody, child support, adoption and other family-law issues, along with advocacy work in the promotion of the GLBT lifestyle. Bruce Hausknecht, judicial analyst for Focus on the Family Action, said this story illustrates the hidden societal consequences of a single act of judicial activism. "In the aftermath of the Massachusetts *Goodridge* decision in 2003...this legal clinic's wide-ranging areas of work reveals (that) no area of family law is off-limits to social engineering (so as to) ... maximize the impact of what the *Goodridge* court decision started." ² ⊕(⊞Romans 1:16,24-27,



In North Carolina, Fayetteville's Veterans Affairs hospital director Bruce Triplett has CLEAR MPACT ordered a Bible and cross be taken out of the Veterans Affairs Medical Center's chapel,

stating that federal directives allow the Catholic articles to stay in the chapel, but not Christian ones. Two veterans have criticized Triplett for ordering the Bible and cross moved from the chapel's altar to the chaplains' office. The two veterans have argued that the hospital is suppressing Christians' freedom of religion by taking the Bible and cross out of the chapel. A Catholic display, including a crucifix, kneeler and Catholic Bible, has been allowed to remain in the chapel, though it has been partitioned off from the main part of the room. Interestingly, crosses are shown in several of the chapel's stained-glass windows. Triplett said those images were OK because the windows also showed other images.
