Note: John Smith Brawner of Sangamon Co., IL died intestate on September 23, 1864, leaving a wife, Ruth, and six children: Martha Jane; John Lewis; Charles E.; Thomas W.; Albert and one whose name is not known.

William B. Tyler [prob. son-in-law], receives "my 2 vols. of Revised Code of 1819 and [illegible] Justice."

REMEMBER WHEN?

- +In October 1988, five young girls were struck and killed by an out-ofcontrol car in the little town of Pulaski, Wisconsin (pop. 2,111). The victims were all 7th graders at Pulaski's Glenbrook Elementary School, whose principal, Jim Brawner, helped the community to cope with the tragedy. Brawner, described as a "big, gentle man who asks a visitor's permission to put his feet on his desk," said two months after the deaths, "It is so easy to say the world is going to the devil in a hand basket, but people were just so good and caring here. They were of so much support to each other, and it was such a comfort to know that." [Chicago Tribune, December 28, 1988, story by Rogers Worthington].
- + In 1972, United Methodists in the United States gave a record amount of money to support worldwide benevolence and administrative programs of the church and two other special offerings, according to a report out of Evanston, IL. **R. Bryan Brawner**, general treasurer of the church, made an announcement of the record giving. [Washington Post, February 3, 1973].
- + On July 10, 1971, Warfield Scott Brawner, 84, died at the Manassas [VA] Manor Nursing Home. Warfield, who was born Dec 19, 1886, had been the owner of the general merchandise store in his hometown of Dumfries, VA. Survivors included his wife, Rowena Merchant Brawner, two daughters and two grandsons. [Washington Post, July 13, 1971].

WEST VIRGINIA EDUCATOR

James Paul Brawner (1902-1984), a long time professor at West Virginia University, is listed in *Who Was Who in America*. Mr. Brawner, a native of Magazine, Arkansas, received his A.B and A.M. from Washington & Lee and his Ph.D. from University of Illinois. He served on the faculty in the English department at WVU beginning in 1935 and chaired that department from 1949 until 1967. Mr. Brawner authored *The Wars of Cyrus* as well numerous articles on English drama and American writers. William Brawner lived in Taney County in southern Missouri for many years. [Reply to *Bulletin*].

Seeking information on the parents and descendants of **William B. Brawner**, b abt 1821 in VA, d abt 1895, possibly in Little Rock AR.. The 1880 Chicot Co. VETERAN IN BAD SHAPE

Alexander Brawner (b 1846 in Ohio d 1928 in Iowa), son of Alexander Brawner (1824-1905) and Mary Ann Morrison, (1826-1860) served with the Union Army in Company H, Second Regiment, Iowa Infantry. In making his claim for military pension over 60 years later, Alexander submitted the affidavit of Dr. F.J. Jarvis, dated April 12, 1926, which stated in part as follows: "That I have this date carefully examined the physical and mental condition of claimant [Alexander Brawner], which is as follows: Claimant is suffering with fracture of joint right hip - injuries to tendons and muscles of said limb - is compelled to use crutches constantly - complains that surgeon who cared for his limb failed to properly adjust broken bone - Leg shrunken and painful in any position - Claimant suffers constantly with muscular rheumatism and results of same -Heart action slow and feeble - liver and kidneys do not function - color poor - lean in flesh, action - dragging motion - complains of poor circulation - constipation and enlarged prostate. This has been his condition for months - said disabilities are permanent. Claimant is feeble and so nearly helpless that he requires the regular personal aid and attendance of another person to aid him in dressing, bathing and moving about."

Note: Alexander "Eck" Brawner married Sarah Ellen Turnipseed in Richmond, Iowa on October 7, 1866. Three children, Cora, Newton and one (name unknown) who died in childhood, were born of the marriage. The couple was divorced in 1878 on allegations that Eck abandoned his spouse. Cora predeceased Eck. Of Newton, Eck said in 1927, "[H]e is a rover, and I do not know where he is. He is single. I last saw him four years ago when he visited me at this Home [Soldier's Home, Marshalltown, Iowa].

Note: Joel Brawner (1798-1866), a native of Elbert Co., GA, is the great great grandfather of Bulletin subscriber Jack T. Brawner. Joel is possibly the son of Basil Brawner of Elbert County, GA. In 1816, Joel married Elizabeth King (1800-1866), a Virginia native, in Elbert Co., GA. Joel and Betsy moved to Cartersville, GA about 1840. Joel and Betsy's children are: Catherine (Tabler); John F. (1817-1894).; Jane (Talbot) (b 1822); Betsy Ann (Saunders) (b 1825); Sarah C. (Baker) (b 1826); William K. (1829-1863); Jesse Johnson (1832-1897); Susan F. (Odom) (b 1835); David G. (b 1837); and Henry M. Brawner (b 1839).

HARRIS GAMMON DEAD

"At the residence of James Cox in this county on the 20th of December, 1843, Mr. Harris Gammon in the 87th year of his age. Another pensioner is gone. Mr. Gammon was one of a noble band engaged in the Revolution struggle. When in youth his active time delighted in the dangers of the tented field: and he was ever found where the enemy threatened, or duty called. When old age came on and he was so oppressed by its weight that he could no longer engage in the active scenes of life, he delighted himself with the thought that he had fought for a country whose freedom had been secured and whose freedom would descend as a rich heritage to posterity: even in the decrepitude of old age, his eyes would glow with all the ardor and enthusiasm of youth, while he relayed the interesting scenes of a bloody war thru which he had passed. He had been a member of the Methodist church 73 years. In the heat of battle he found his God a support in the perplexity of life and a relief(?) and in the hoary hairs of life a peaceful comforter. He ever showed the world that he was not ashamed of the cause he had so early espoused. When he was conscious that his end was near, he told his afflicted children and grand children, to weep not for him, that he was going to a better world, and rejoiced to the last that he could recommend the religion he had so long professed to his dying fellowmen. Thus after boldly defending the liberties of his country and earnestly contending for the Kingdom of Glory, having suffered a few days of acute pain, he sweetly fell asleep in the arms of the Blessed Savior, leaving an example worthy of imitation." [Knoxville (TN) Register, January 17, 1844][Thank you to Jack T. Brawner].

Note: Harris Gammon (1757-1843) was the spouse of Levicy Elizabeth Brawner (1760-1826). Both were natives of Pittsylvania County, Virginia. Harris' father is believed to be John Brawner Gammon, a native of Norfolk Co., VA.. Harris served in Capt. Peter Perkins Co. and in Capt. William Dix's Regiment of Charles Williams Co. and saw service in the siege of Yorktown. He and Elizabeth had 12 children, and have numerous descendants throughout Tennessee, Texas and several other states.

FIGHTER & PIONEER

Theopolis Brawner (1789-1866), the son of Edward Brawner (b 1762) and Ann Franklin (d 1797), served in the War of 1812 as a Private in Capt. Dunnington's Co. and Capt. Thomas Burgess' Co., Maryland Militia. Thereafter, Theopolis migrated to Kentucky, where on November 9, 1820 he married Rachel Wade (b May 8, 1801 in KY, d after 1880) in Shelby Co., KY. The couple had four children: John Edward Brawner (b 1821, m Margaret Pulliam); Mary Jane (b 1823, m James D. Moore); William Royal Francis (1825-1905); and Margaret Ann (1842-1934, m Charles W. Duvall). Theopolis died in Franklin Co., KY on December 17, 1866.

DEATH AT BRAWNER HOUSE

"He suffard a grate deel before he died"

"Cartersville, GA, Aug 2, 1878

Dear Sister and family,

I take my pen in to drop you a few lines to let you that we are all well and to let you know that Father is dead. He died the 29 of July. He soad som Oats up at his Pine Log place and went up there to bring them home and the mules ran away with the wagon and threw him off and hurt him so that he died from it. He got hurt on Tuesday eavning and lived until the next Monday morning. He died at John F Brawners on Monday at 10 1/2 OClock and we brought him home Tuesday and buried him Wednesday. He never talk but very little after he got hurt, thougt he called all his childring by there names. He died perfectly easy and I think that he has gon to rest for Lou ask him if he would go to rest and he could not speak but he smiled and Nan I want you to give him up cherful for it was the Lords will at tak him and we could not hinder him from going. * Simpson & Weiner's *The Oxford English Dictionary, 2d ed. (Clarendon Press, Oxford, 1989)* says that a "brawner" is a "boar fattened for the table." The dictionary quotes Welsh King Cookery saying in 1708, "Send up the brawner's head." [Thank you to George F. Brawner, Sr.].

* In May 1912, **Robert Alexander Brawner II** (1872-1921), coal merchant and prominent politician in Frankfort, KY, submitted the winning bid of \$206 for the historic little red brick building on the State House Square in Frankfort. Mr. Brawner, as purchaser, was required to tear the building down within 90 days. [Frankfort News-Journal, May 7. 1912][Thank you to **Ruth Kirk Ramsaeur**].

WILL OF HENRY BRAWNER of Charles County, Maryland

"In the name of God Amen. I Henry Brawner of Charles County, and State of Maryland, do make, ordain and declare this Instrument to be my last Will and Testament ... I give and bequeath to my grandson William Henry Brawner McPherson, one negro man..., one woman ..., one boy ... [and three girls], one young horse ..., and one eight day mantle block.

Item. I give and bequeath to my grand daughter, Susanna Etheldra McPherson, one servant girl named Margaret.

Item. I give and bequeath to my grandson, Edwin Thomas Wilmer McPherson, one negro man ... and one boy.

Item. I give and bequeath to my grandson, Henry Middleton Brawner McPherson, one negro man ... and one girl

Item. I give and bequeath in equal division between my three grandchildren, the children and heirs of my son Henry Middleton Brawner [eight servants] ...

Item. I give and bequeath in equal division between my seven grand children, the children of my daughter Joanna S. McPherson and the children of my son Henry M. Brawner, all my household and kitchen furniture, stock of all description and farming utensils, except as ... is already disposed of.

Item. I give and devise to my grand son William H. B McPherson [the remainder of my property].

And lastly, I do hereby appoint William H. B. McPherson Executor ...

I have hereunto subscribed my name and affixed my seal this 17th day of December, [1842]. [Signed], Henry Brawner Witnesses: Pearson Chapman, George Dement, Basil Gates." [Probated January 3, 1843].

Note: This appears to be the Henry Brawner who was born in 1774, probably in Charles Co., MD. His parents are possibly Bennett Brawner (d 1777) and Mary Ann Ratcliff of Maryland. Henry's son, Henry Middleton Brawner, a Charles County lawyer, was born in 1807 and died in 1836 in Charles County. Henry Sr.'s daughter is Joanna Freeman Stoddert Brawner.

WOOD MERCHANT

Basil Brawner, born about 1798, died on the morning of March 7, 1837 at his home near the River Bridge in Georgetown, Potomac Washington, D.C. Basil, probably the son of William Brawner (d abt 1784) of Charles Co., MD. married Eleanor Harrison Beatty on June 17, 1830. Eleanor was the widow of Alexander Semmes, the owner of a large sailing fleet with Georgetown as his home port. Alexander Semmes was lost at sea in about 1826. Basil and Eleanor had four children: William Henry (1831-1916); Mary Catherine; Joseph (1834-1844); and Ann **Jane**. In 1834, Basil is shown in the Georgetown, D.C. directory as a "Wood Merchant" living in a dwelling house at Bridge St. Also listed at that year at that address is a "J. Brawner," perhaps Basil's brother.

Basil died without a will. The administration of his estate shows numerous receipts for money paid to Eleanor for the maintenance of the surviving children, including \$25.00 for 6 months boarding of each child, \$12.50 for 6 months' clothing and varying amounts for tuition. The administration includes money received by Eleanor and the children from the surviving partners of B. Brawner & Co., with Eleanor receiving \$2,222, William Henry receiving \$741, Ann Jane receiving \$242 and Mary Catherine receiving \$10. [Thank you to A.H. "Harry" Brawner and Marianne Smyth].

Note: The Fall Bulletin incorrectly reported on page 7 that this Basil Brawner was born in 1803 and died after 1870. In fact, there was a Basil Brawner of Prince William Co., VA who was born in 1803 and died in 1892.
