**AKC Canine Good Citizen (CGC) Test, 10 AM – 12 Noon**

Pre-entries accepted until May 12, 2003. Day of test entries accepted until 11:45 AM. Open to dogs of all breeds— "All-Americans" welcome! Bring a brush/comb, and a copy of dog's current rabies certificate & town license.

*Rabies tag alone is not sufficient.* Fee \$12. Portion of the proceeds to benefit a local service/therapy dog organization.

Shade & water available.

Bring chairs & lunch; drinks available for purchase.

**Directions** *From the west:* via Mass. Pike, take exit 14 and follow signs to Route 128 (I-95) and Route 30. Take exit to route 30 East (towards Newton). Go one mile east on Route 30. Turn left at lights (Lexington Street) and bear left at the fork onto Freeman Street. Turn left onto West Pine Street and follow to end.  
*From the east:* Take Commonwealth Ave (Route 30) to Lexington Street. Turn right at the lights, and then bear left at the fork onto Freeman Street. Turn left onto West Pine Street and follow to end.
