SPECIAL NOTICE: ALTERNATE ENTRIES

In accordance with AKC Regulations, entries in this tracking test will be accepted up until the official closing date, even though the advertised limit has been reached.

A drawing will be held at the home of the event secretary, Roni Szeliga, 1822 22nd Street, Kenosha, Wisconsin, on April 2, 2009, at 6:00 p.m. to determine which entries will participate in the test.

This drawing, conducted by the event secretary, shall be completely at random from among the entries received, except that preference shall be given to those entries which have not earned a VST title.

When the advertised limit has been drawn, all remaining entries shall be similarly drawn and assigned a position on the alternate list, subject to the same preferences set forth above.

The event secretary shall notify all entries of the result of the drawing. Alternates have the option to accept or decline being placed on the alternate list. Those who opt to decline shall have their entry fees returned upon written notification to the event secretary of their intention to withdraw from the alternate list.

If an accepted entry cancels after the closing of entries, the event secretary shall contact alternates in the order of their placement on the alternate list. Upon such notification, alternates shall have the option to accept or decline the opportunity to participate in the test.

No entry fee will be refunded except that of an alternate who does not participate in the test. Exception: If an accepted entry withdraws from the test and an alternate replaces that entry, refund will be made to the withdrawn entry.

If an accepted entry is absent on the day of the test, it shall be the responsibility of the event secretary to determine if alternates are present and to determine, by their position on the alternate list, which of the alternates will participate.

Bitches in season will be permitted to run and will be assigned to the last track(s). The assignment of dogs to the tracks is the responsibility of the judges.

Dogs must be on lead at all times in any area of the tracking site.
