**DIRECTIONS TO TEST:**

The Ottawa Field Trial Grounds are located approximately 5 miles north of Eagle, WI on Rt. 67.

- From the Waukesha Area – take I-94 west to Hwy. 67. Take Hwy 67 south to site, just past the intersection of Hwy 67 and Cty C/106
- From the Chicago Area – take I-94 to Hwy 50. Take Hwy 50 west to Rt 12. Take Rt 12 north to Hwy 67. Take Hwy 67 north through Eagle, about 5 miles to site.
- From Janesville-Beloit Area – Take Hwy 15 to Rt 12. Take Rt 12 north to Hwy 67, and Hwy 67 north through Eagle, about 5 mile to site.
- From Madison Area – Take I-94 east to Hwy 67. Take Hwy 67 south to site, just past the intersection of Cty C/106.

## **SPECIAL NOTICE: ALTERNATE ENTRIES**

In accordance with AKC Regulations, entries in this tracking test will be accepted up until the official closing date, even though the advertised limit has been reached.

A drawing will be held at the home of the test secretary, Nancy Foster, 1080 White Rd., Antioch, IL, on Thursday May 21, 2009, at 4:00pm, to determine which entries will participate in the test.

This drawing, conducted by the test secretary, shall be completely at random from among the entries received, except that preference shall be given to those entries which have not earned a TD title.

When the advertised limit has been drawn, all remaining entries shall be similarly drawn and assigned a position on the alternate list, subject to the same preferences set forth above.

The test secretary shall notify all entries of the result of the drawing. Alternates have the option to accept or decline being placed on the alternate list. Those who opt to decline shall have their entry fees returned upon written notification of the test secretary of their intention to withdraw from the alternate list.

In the event an accepted entry cancels after the closing of entries, the test secretary shall contact alternates in the order of their placement on the alternate list. Upon such notification, alternates shall have the option to accept or decline the opportunity to participate in the test.

No entry fee will be refunded except that of an alternate who does not participate in the test. Exception: In the event that an accepted entry withdraws from the test and an alternate replaces that entry, refund will be made to the withdrawn entry.

In the event an accepted entry is absent on the day of the test, it shall be the responsibility of the test secretary to determine if alternates are present, and to determine, by their position on the alternate list, which of the alternates will participate.

The assignment of dogs to the tracks is the responsibility of the judges.

**The Ottawa Field Trial Grounds are a part of the Wisconsin State Parks system, and as such a daily or annual permit is required for entry into the grounds. Daily permits may be purchased on site. The cost is \$7.00 for Wisconsin and \$10.00 for non-residents per day. Annual and daily permits may also be purchased at any WI State Park Ranger Station.**
