

Pond Restoration Plan

The EHSA Board, working with New England Environmental, Inc., (NEE) is embarking on a three year, \$30,000 pond restoration plan. The goal of the restoration plan is to extend the life of the EHSA's upper, middle and lower ponds by 30 years. Highlights of the 3 year effort include a design phase, a permitting stage, a three pronged fundraising plan and a phased pond dredging schedule.

2000-2003 efforts to restore ponds

The pond restoration planning now underway follows on the heels of a Amherst Conservation Commission approved pond remediation plan implemented by the EHSA Board from March 2000 through March 2003. This plan included the cutting of the invading brush around the edges of the ponds up to the spring high water mark, opening a trail along the side of the lower and middle ponds, reopening the public access to the upper pond, and some minor hand dredging in the lower pond.

2003 conclusion: Dredging only option to save ponds from becoming marshes

At the conclusion of the March 2000 - March 2003 remediation plan, and following two years of drought, it became clear that more extensive action was required to save the ponds. At this point, all experts consulted agreed that mechanical dredging was the only long term, cost-effective solution available. NEE was chosen to help develop a comprehensive plan based on their excellent reputation and local work, including Echo Hill North's swimming pond, the UMass pond and the Mt. Holyoke College pond. Over the last 6 months of 2002, the EHSA Board's Pond Committee has worked with pond abutters, the Board and the NEE to develop both a pond restoration plan and a fundraising plan.

Restoration schedule, if permitting and fundraising efforts are successful

When the appropriate federal, state and local permits are granted this spring, and if fundraising has been successful, a phased dredging of the ponds will begin in the late summer or early fall of 2004 when the ponds are typically at their lowest level. Dredging will begin with the upper pond, bordered by Cranberry and Laurel Lanes. In late summer of 2005, both the middle and lower ponds will be dredged. An unusually wet summer and fall could prevent dredging in a given year, and the schedule will be pushed back

until the following year. The permits for this project are good for 3 years, and can be extended due to such extenuating circumstances.

Restoration approach aims for healthy, safe and enjoyable ponds

All of the ponds will have most of the accumulated sediment removed from them. Each of the ponds will have deep areas created near their centers for the purpose of maintaining a year round water area to support animals and plants which need constant immersion. Some areas around the edges of the ponds and areas with healthy, native plant life will remain as is. All of the ponds will have harmful invasive plants removed. Beneficial native vegetation will be

transplanted within the ponds to hasten the flora and fauna recovery. In addition, all ponds will have shallow buffer zones along their edges to provide transition zones for aquatic life and a safety zone for children. Access areas for fishing and pond viewing will be improved. A nearby butterfly garden is under consideration.

Three pronged fundraising effort: Abutter contributions, EHSA dues surcharge and EHS community donations

A three-pronged fundraising plan will begin this spring to raise the \$30,000 needed to save the ponds. Funds will be obtained from the primary abutters of the ponds, from an EHSA Association dues surcharge and from local individual and business donations. The primary abutters, whose aesthetic experience of the ponds and property values will be significantly improved by the pond restoration efforts have been asked to contribute 50% of the total cost, or \$15,000. A major portion of those funds have already been pledged. The EHSA Board has approved a three year surcharge on dues of \$10 per year, for a total of \$30 per Association member over three years. The dues surcharge will fund \$7500 of the restoration costs. The remaining 25%, or \$7500, will be raised from EHSA members, businesses who serve the EHS community, as well as the now-grown children who grew up in EHS and enjoyed the ponds. One fundraising effort you can see in this newsletter is selling advertisement space in this and future issues.

A Thank You and ... A Reminder About Dogs

Thank you for a cleaner common field!

Since the installation of our "Clean up after your pet" signs at the entrance areas to the common field, the field has been much cleaner. *Thank you dog owners!*

A friendly reminder on restraining and leashing your dog:

It is the law as well as being necessary for safety that all dogs be either restrained on one's property, or if off of one's property, under leash or voice control. There are a growing number of small children in EHS. There are also a few dogs that either frequently escape or who are allowed to roam at times. While no injuries or incidents have been reported recently in EHS, we'd like to remind dog owners to follow Amherst bylaws, excerpted below.

Town of Amherst Animal Welfare Bylaw

4. Dog Regulations

- A. It shall be a violation of this bylaw for which the owner/guardian or keeper shall be liable for a dog to:
- i. go beyond the confines of the owner/guardian's or keeper's property unless the dog is held firmly on a leash, or is under the control of its owner/guardian or keeper, subject to restrictions of Section 5.A. [dog must be leashed at all times in public parks]
- ii. disturb the peace or quiet or endanger the safety of any person or other animal, by biting, barking, howling...

The Natural Setting of Echo Hill South Common Land

The designers of our PUD (Planned Unit Development) or Clustered Housing Concept provided us with a valuable and unprecedented asset that is usually only available to estate owners or in public parks, not near private middleclass homes. It was in the plan of the EHSA developers to provide us with this novel experience and designed into the very legal basis of our existence. Our houses are designed, clustered closer together, with the understanding that we maintain free and open common land amidst the cluster. Therefore we have our large fields and ponds that we hold in




A watercolor depicts a hummingbird at cardinal flowers at the edge of one of our ponds. Gerda Kunkel

The 'Tragedy of the Common' as applied to our Association suggests that we might allow our common land to degrade because no one takes the responsibility to care for it despite our mutual benefit from it. The End of Busing as We Know It?

In mid-February the PVTA held a hearing in Amherst (and elsewhere) on plans to curtail significantly bus service along several routes including the Gatehouse Road (route 36), which currently provides limited bus service between Echo Hill North and South, the center of Amherst, and the University of Massachusetts six times daily, Monday to Friday. Because bus service runs only early in the morning and in the late afternoon/early evening, the busses are not heavily used when



driving through the Echo Hill neighborhoods. A midday run was dropped several years ago.

The EHSA Board of Directors voted to appeal to the PVTA and the UMass Transit Service not to end service in Echo Hill, but to consider merging the route with the current Belchertown Road Express Service by having those busses turn up Gatehouse Road and follow the current Gatehouse Rd. route to Pelham Road and into town and the university and the reverse when heading toward Belchertown Center. In addition to morning and late afternoon "commuter" trips, such a combined route would add two midday/early afternoon busses to and from the Echo Hill neighborhoods and increase ridership by those who do not want to spend a full day in town or at the university. It would also allow those without cars to shop in Belchertown (e.g. at the new Stop and Shop) as well as Amherst.
