- Baggage handling (1 piece per person).
- English speaking escort / guides.
- Coordination by the *PFMC* throughout the pilgrimage assisting with arrangements for daily Holy Mass and spiritual activities.
- All guided tours and admission fees.

**NOT INCLUDED:**

- Lunches, snacks, drinks, special meals, alcoholic beverages, personal items, etc.
- Travel Insurance.
- Tips or Gratuities.

➤ All registrations require full \$580 donation by cash, check made out to *PFMC* and sent to 61 Cooper Road Voorhees, NJ 08043-4963 or, charge to MasterCard, Visa, or Discover. The *PFMC* asks that any charges be accompanied with a 3% additional donation to cover handling fees.

➤ Donations to the *PFMC* for self or others may be solicited and collected to support those who cannot afford this pilgrimage. For more information, use the Internet to visit <http://www.geocities.com/pilgrimsfaith/DonReq.pdf>.

➤ Travel insurance is **NOT INCLUDED** because the cost is age dependent as in most insurance. An excellent package is available and is highly advisable. Policy application forms with costs that range from \$36/\$61 to \$145/\$305 for Part A/Parts A&B for ages ≤30 to ≥81 will be sent with registration confirmation letters to each pilgrim.

➤ Special meals or dietary arrangements are **NOT INCLUDED**. These must be arranged for *at least 10 working days* before pilgrimage departure. Lunches and snacks as well as alcoholic beverages are **NOT INCLUDED**. Plan about \$10 for a light lunch and about \$20 for hot lunch.

➤ Single Supplement (private room) requires an additional \$175 per person to be included with deposit.

➤ Transportation to/from Saint Theresa Church is **NOT INCLUDED**. Overnight parking is not permitted without prior arrangements with the church officials. Local limousine service information and a willingness to coordinate pilgrim transport to the motor coach departure point is available from the *PFMC*.

➤ Tips or gratuities for the guides, hotel / religious house staff, and motor coach driver are **NOT INCLUDED**. Plan on about \$50. Pilgrims are always welcome to add extra tips or gratuities for particularly good service.

➤ A medical information sheet will be sent with confirmation of each pilgrim's registration. Need for wheelchair or other medically approved assistance must be stipulated with medical documentation from a medical provider. A *PFMC* nurse will speak to each pilgrim needing special assistance to assess the individual need. This must be approved prior to registration confirmation.

➤ A *PFMC* or agent coordinator, escort, or guide will be with this pilgrimage group and available for questions about scheduling, rooms, and motor coach transfers. He or she will assist and coordinate the daily program.

➤ Proof of identity at the Canada border will shift to passports on 1 January 2006. Driver's license or birth certificate will suffice for this pilgrimage.

➤ Send all completed forms with a photo copy of each pilgrim's passport photo page, with computer code at bottom of page visible in photo copy, or driver's license, or birth certificate to the *PFMC*, 61 Cooper Road Voorhees, NJ 08043-4963 as soon as possible to make sure all pilgrimage needs are met.

## PLANNED ITINERARY:

Time will be set aside daily for **Holy Mass, Angelus, Rosary, Divine Mercy Chaplet, Liturgy of the Hours**, etc.

**MONDAY, 10/24/05:** Depart **Saint Theresa Church**. Travel to **Canada**. Upon arrival at your **Montreal** hotel, a local **Tour Guide** will greet you and assist with check-in. After settling in, enjoy an included **dinner** at an area **restaurant**.

**TUESDAY, 10/25/05:** Enjoy an included **breakfast**. After your meal, depart on a **Tour of Montreal** and view **Notre-Dame Cathedral** (one of **Montreal's** most famous landmarks), and **Saint Joseph's Oratory** resting high on **Mount Royal** since **1904**, along with many more of **Montreal's** finest such as **Bonsecours Market, Olympic Park, and the Old Port**. Enjoy free time in **Old Montreal** (**European Architecture** dating back to the **17<sup>th</sup> and 18<sup>th</sup> Centuries**), and have **lunch on your own**.

Later, travel to **Quebec** for a **two-night** stay. Upon arrival at your **Quebec** hotel, a local **Tour Guide** will greet your group and assist with check-in. After settling in, enjoy an included **dinner**.

**WEDNESDAY, 10/26/05:** Start the day with an included **breakfast**. After your meal, depart for a **Tour of Quebec City** to view the **Citadel, Chateau Frontenac, Old Quebec** (offering a panoramic view of the **Saint Lawrence River**, the historic plains of **Abraham**, and quaint sidewalk cafes), **Place Royale**, and the **Old Port**. Enjoy **lunch on your own** while touring today. Visit **Saint Anne de Beaupre Shrine** and take in the best of **Quebec**.

Continue on to **Montmorency Falls**, a breathtaking cascade higher than **Niagara**. Return to your hotel to relax and freshen up before **dinner**. Enjoy an included **dinner** this evening at an area restaurant. Also this evening, enjoy a **3-D presentation** of **The Quebec Experience**.

**THURSDAY, 10/27/05:** Enjoy **breakfast** this morning at the hotel. After your meal, enjoy free time to explore **Quebec** on your own and do some shopping or enjoy a cup of coffee and a delectable French pastry on your own! Visit **Our Lady of the Cape** – a place of miracles. This afternoon, return to **Montreal** for a final overnight stay. This evening, enjoy an authentic **dinner** and entertainment at **Le Festin Du Gouverneurs**. Return to your hotel.

**FRIDAY, 10/28/05:** Start the day with an included **breakfast**. After your meal, bid **farewell** to your **Tour Guide** and depart on a safe journey home with fond memories of your **Montreal** and **Quebec** pilgrimage!

# TERMS AND CONDITIONS

**DONATION AND REGISTRATION:** A \$580 per person donation is required at the time of booking a registration, with pilgrim's full name (as it appears on identification papers such as driver's license, birth certificate, or passport), mailing address and telephone number. Fax, internet / e-mail, or phone registrations are welcome. Donation in full must be received within **7 days** of registration by means other than mail or the registration will not be processed and will automatically cancel.

**FORM OF DONATION:** Credit Cards (**Discover, Visa and Master Card**) or Personal / Bank / Certified / Travelers Checks, or Money Orders, or Wire Transfers (please fax a copy of bank confirmation when wiring funds) are accepted forms of donation at any time. Credit Cards (**Discover, Visa and Master Card**) will incur an additional **3%** charge to cover the processing fees. Every registration must be accompanied by a signed application form (previous page). Returned checks will incur a **\$25** service fee. In case of computer or human billing error, we reserve the right to re-invoice with corrected billing.

**NOT INCLUDED:** Items of a personal nature, such as telephone, room service, lunch, snacks, drinks, alcoholic beverages, optional activities, and laundry. Tips to guides (~\$5/day) and drivers (~\$2/day per bag) and medical / travel insurance (\$ varies based on age and package cost). Please carefully review all pilgrimage information.

**TRAVEL DOCUMENTS:** A valid passport, driver's license, or birth certificate is required for travel. If you are not a **US** citizen, please consult your local **Canada** embassy or consulate for visa requirements. Cancellations due to lack of appropriate travel documents will incur usual penalties.

**CANCELLATIONS AND REFUNDS:** In addition to a \$50 administration fee for all cancellations, the entire donation is not refundable if cancellation is made within **30 days** of departure. Requests for a refund must be in writing. Phone calls must be backed up by FAX of the written request for cancellation that is to also be mailed. It is the individual pilgrim's responsibility to confirm *Festive Holidays* and *PFMC* receipt of cancellation requests. Refunds will be issued within **60 days** of receipt of written notice of cancellation containing proper medical documentation. Refunds for donations made by credit card are subject to an additional **3%** fee.

**CANCELLATION BY OPERATOR:** Be clearly advised that from time to time a pilgrimage departure may be cancelled due to lack of participation. In such case, the operator's sole responsibility is to provide a refund. *Festive Holidays* and the *PFMC* are not responsible for conjunction tickets (not purchased from *Festive Holidays* or the *PFMC*).

**OTHER CANCELATIONS:** Cancellations due to **U.S. Department of State** travel advisories and/or travel warnings, Acts of War, War, Terrorism, Acts of God, Natural Disaster, or any other circumstance outside the control of *Festive Holidays* and the *PFMC*, are not the fault of *Festive Holidays* and the *PFMC*. Cancellation for any of these reasons will not be eligible for any form of refund. *Festive Holidays* and the *PFMC* strongly recommend medical / travel insurance which contains cancellation provisions.

**SPECIAL MEDICAL CONDITIONS:** *Festive Holidays* and the *PFMC* cannot guarantee special facilities or assistance for disabled pilgrims. It is the individual pilgrim's responsibility to arrange for such assistance as they may require. *Festive Holidays* and the *PFMC* can not held responsible for any medical condition that occurs prior to, during, or after the pilgrimage. *Festive Holidays* and the *PFMC* strongly recommend medical / travel insurance.

**MEDICAL / TRAVELER'S INSURANCE:** *AccessAmerica* and **M. H. Ross Travel Insurance Services Global Alert Travel Protection Plans** are available through the *PFMC*. *Festive Holidays* and the *PFMC* are not liable for the policies, decisions, procedures, etc. of any insurance company. It is the sole responsibility of the individual pilgrim to request and review each insurance brochure. Policies and restrictions imposed by the insurance company are not limited to that which is stated

in the brochure. Medical / Traveler's Insurance purchased through the *PFMC* recommended companies will only cover the services, expenses, arrangements, arranged by *Festive Holidays* and the *PFMC*. For additional clarifications, restrictions, regulations, etc. please contact the insurance company directly.

**DEVIATIONS, REVISIONS, AND CHANGES:** You may deviate and design your own optional post-pilgrimage travel and accommodations at additional cost. Please contact *Festive Holidays* or the *PFMC* for further details and pricing.

**BAGGAGE:** The less the better. If in doubt, leave it at home. Each pilgrim is advised to bring one suitcase and one small overnight bag. *Festive Holidays* and the *PFMC* are not responsible for loss, theft, delay, or damage to a baggage.

**SEAT ASSIGNMENT:** No seat assignments have been made for any pilgrims. The tour coordinator and guide need to sit in the front seats. If you would like to secure a specific seat, or sit with a companion, please have all parties at the motor coach departure point at least an hour prior to departure and try to arrange desired seat selection.

**NO SMOKING:** No smoking is allowed on the motor coach.

**HOTEL ACCOMMODATIONS:** Hotel accommodations are based on twin-bedded rooms; double beds are possible. *Festive Holidays* reserves the right to substitute similar category hotels or religious houses without prior notice. No reductions are available for triple rooms.

**SINGLE SUPPLEMENT:** A limited number of single rooms are available at the single supplement price listed. For this pilgrimage it is **\$175**.

**MEALS:** There is no refund for unused meals. *Festive Holidays* and the *PFMC* can not guarantee special meal / diet requests can be met.
